Add a draft time entry to track time for potential clients or matters. Capture your time while you wait for the matter to be created.

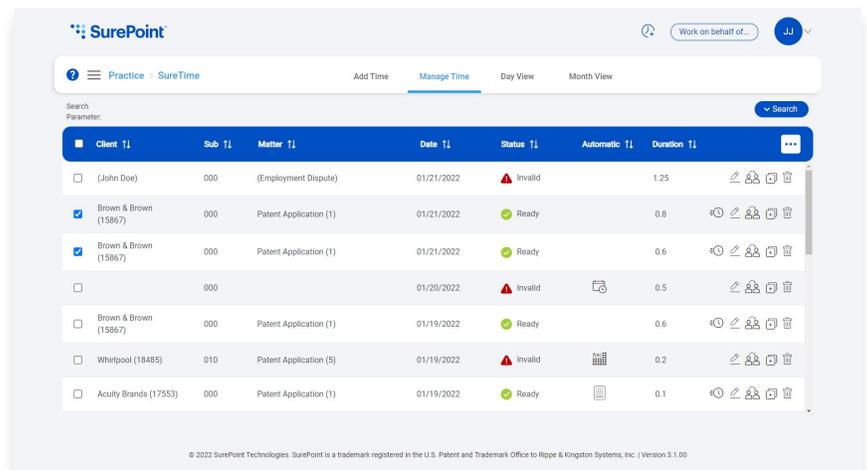

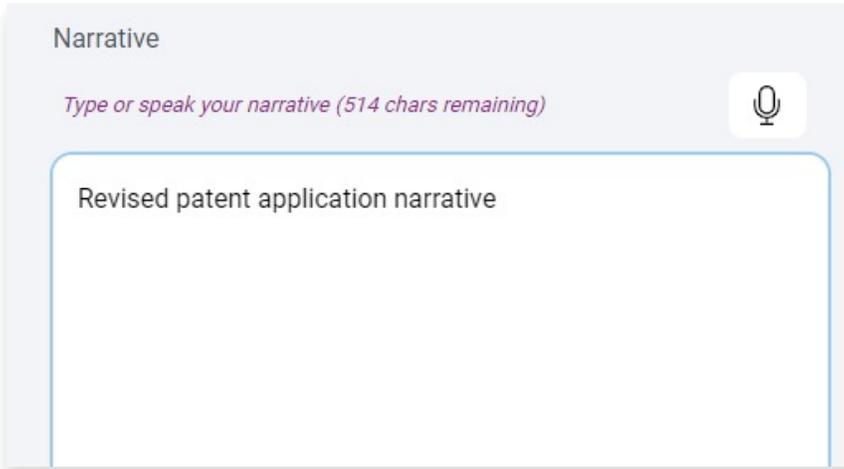
Manage Time

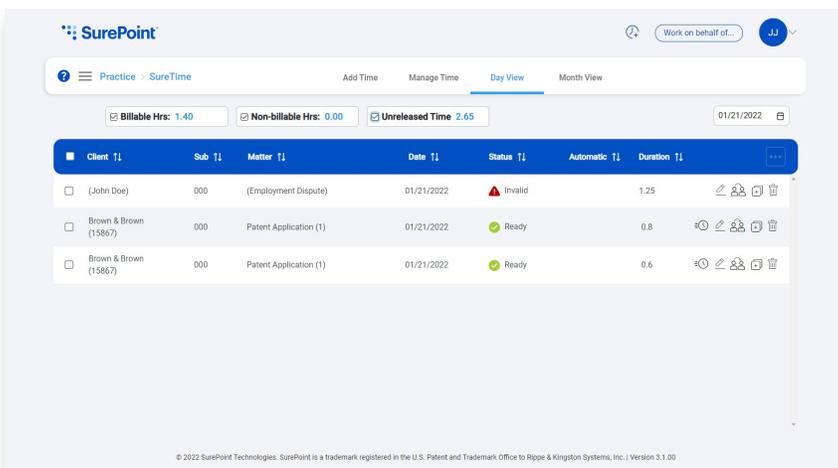
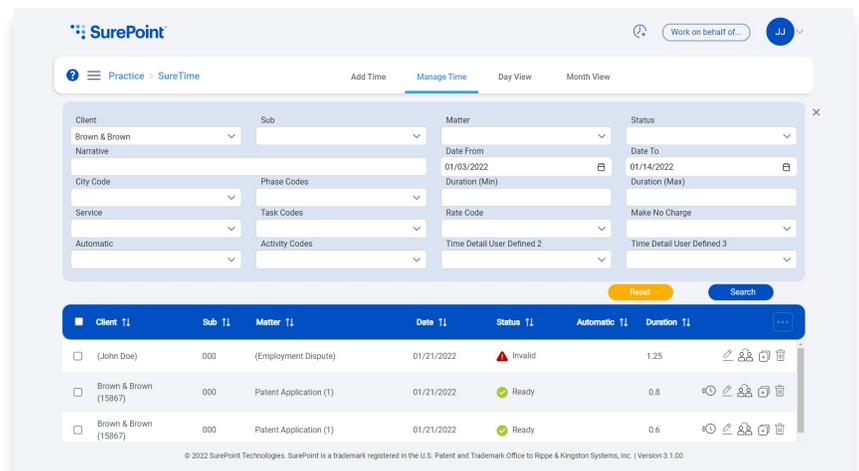


Narrative

Day View

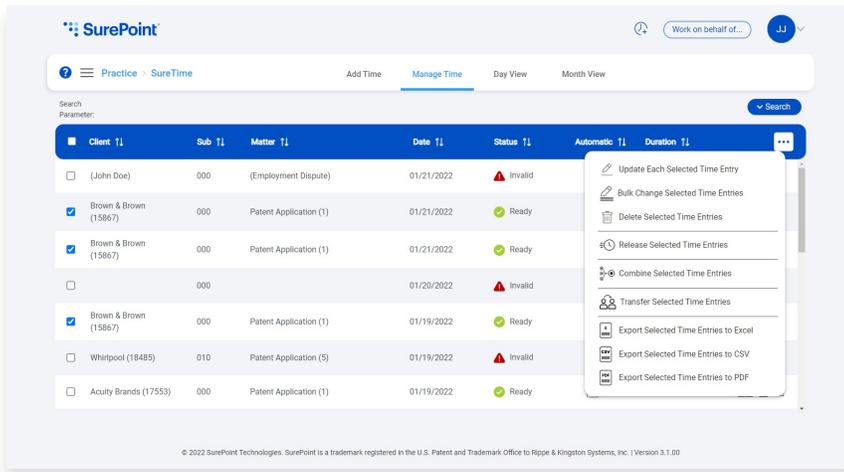
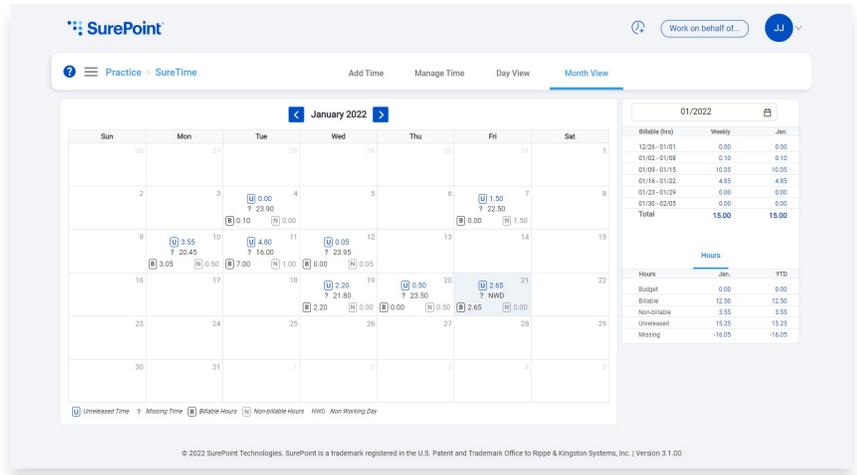
See an overview of time entries for a specific day. The total billable, non-billable, and unreleased hours and dollar amounts are displayed.
